
## OBJECT CLAUSE

1. 3. To provide counseling facilities to the youth to select appropriate career path so that they can leverage maximum benefit out of their education.
4. To assist the unemployed youth in finding jobs or becoming self-employed through the establishment of Employment Bureaus and other facilities needed and to create awareness on carrier options and to provide the opportunities under Government schemes and to work for the youth development activities.

7. To promote education for poor and deserving students by grants of scholarship to students and Educational Loan without Interest.
8. To align, associate, network with any university or educational Institutions for the objects mentioned above.
9. To extend Middle School and Higher Secondary School by admitting more students and extend buildings for the accommodation of the students as per the Educational Rules of the Government
10. To extend the Higher Secondary school to Secondary Grad Teachers Training Institutions and Construct adequate building for the purpose as per the Rules of the Government

#### **4. Sources for the trust:**

## 5. APPLICATION OF INCOME:

- a) The income and funds of the trust will solely be utilized towards the objects & no portion of it will be utilized for payment to the author, trustees, members of the committee, office bearers by way of profits dividends, interest, bonus etc., or otherwise.
- b) Corpus Fund or Capital Fund or Earmarked fund shall be invested in such manner as prescribed under section 11 (5) of the income Tax Act 1961 till the fund is defrayed for capital or revenue expenditure for the maintenance and sustenance of the objects for which the fund is created.
- c) Where the income of the relevant year is not applied for educational purposes the trust may accumulate or set apart either the whole or part of its income for future application for the purposes of the trust by complying the provisions of the Income Tax Act, 1961.

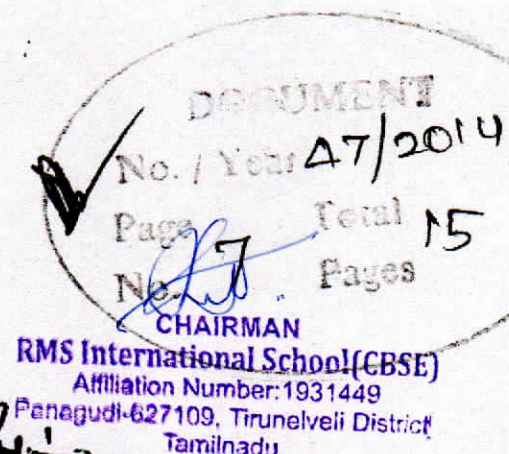

6. To keep proper minutes of the proceedings of the Board and advisory Board and resolutions carried in the meetings.

## 9. BANK ACCOUNT:

## 11. ADVISORY BODY AND COMMITTEE:



## 18. NEW TRUSTEE:

## 19. DISSOLUTION OR WINDING UP:

In the event of dissolution or winding up of the trust, the assets remaining as on The date of dissolution shall not under the circumstances be distributed among the author, trustees, committee members but the same shall be transferred to another trust whose objects are similar to those of this trust and which enjoys recognition under section 80G of the Income Tax Act. i.e. the assets / liabilities will be transferred to a trust not only having similar objects but also enjoying exemption u/s 80G of the I .T .Act at time of transfer.

## 20. OTHERS:

The trust shall under no circumstances do or venture into any business directly or indirectly and as such the question of maintenance of separate books of account , compliance of the provisions of section 11{4}And proviso to section 80G {5} {i} of the Income Tax Act, 1961 does not arise.

The initial amount settled upon the trustee is Rs.1000/-(rupees one thousand only) on which the stamp duty has been paid .At present the trust has no other moveable or immovable property except the nucleus amount of Rs.1000/-. 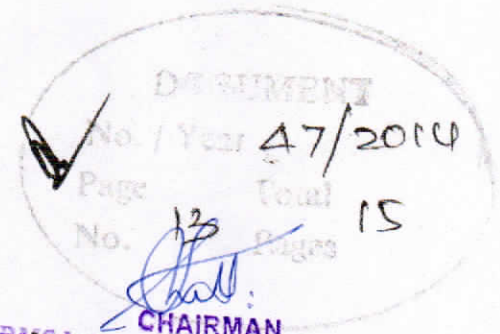
